- Manuscript Submission** Manuscripts original in style and content (not under review, accepted and/or published elsewhere) are welcome. Prospective authors are strongly encouraged to submit their manuscripts in English. However, should that prove difficult, manuscripts in languages other than English may be submitted. In such a case the paper will go through a pre-review process to determine its fitness with OS editorial policy and quality standards. If a paper has potential, its authors will be asked to translate it into English and then the English-language version will be submitted to the normal review process. Papers should be submitted only electronically as Microsoft Word email attachments and, if possible, as PDF files. Papers should be written in accordance with the journal's requirements (see Editorial Procedures & Manuscript Submission on the website, www.egosnet.org/os).
- Terms of Publication** Before publication authors are requested to assign copyright to SAGE Publications, subject to retaining their right to reuse the material in other publications written or edited by themselves and due to be published preferably at least one year after initial publication in the Journal.
